Caravan Site Notes & Regulations

Only one caravan application per exhibitor



The site will be closed from 10pm to 8am each night and no access will be allowed during this period.

In the event of an emergency please contact the show society caravan warden on 07840 209336

1. All caravans, mobile homes and tents must be fitted with or carry a fire extinguisher
2. Caravan passes are not transferable and must be prominently displayed at all times.
3. All pitches are marked by lines and all outfits must be parked between these lines as directed by Caravan Steward.
4. Any external extensions other than awnings, such as awning annexes, windbreaks, gazebos etc are at the discretion of the caravan steward.
5. Awning facing awning set ups will NOT be permitted.
6. Users will be allocated a space of 30ft (10mtrs) in width and the caravan and all associated equipment and vehicles MUST be contained within this space.
7. All dogs must be kept on the lead at all times while within the caravan site or showground and it is the responsibility of the owner or handler to ensure any fouling is cleared up.
8. All access roads both on the perimeter and within the site must be kept clear at all times to allow access for emergency and service vehicles.
9. Ball games are not permitted within the vicinity of the caravans.
10. Barbeques are permitted, but no open fires. BBQ's must be used responsibly and sited so as not to pose a fire hazard. Users must ensure that they are fully extinguished after use.
11. All rubbish and refuse must be deposited within the skips provided. Waste water and chemical toilet waste must be disposed of at the points provided adjacent to the toilet block.
12. Generators are permitted between the hours of 7.30am and 11.pm.
13. Tables and chairs supplied for the dog show are the property of BUAS and under no circumstances should they be removed from the showground.
14. The speed limit on the caravan site is 5 MPH and on the showground is 15 MPH.
15. No dogs, no dog grooming or dog bathing is allowed within any of the toilet and shower blocks.
16. No commercial activities are allowed on the caravan site unless prior permission has been sought and given by the show management.

All caravans, mobile homes and tents must report to the Caravan Steward on arrival.

Caravans will be admitted from 0800hrs on Monday 10th June 2024 and must be removed by 12 Noon on Monday 17th June 2024.

After arrival, please advise the caravan steward of the row letter or number where you are pitched. This will allow us to contact you quickly should we need to.

Arrivals after 10pm and before 8am should go to the overnight parking area, which will be clearly signposted. Overnight parking will not be allowed on Friday 14th June or Saturday 15th June.

During show set up access to the showground is limited and all dogs must be kept on a lead and under control at all times.

Care must be taken to avoid vehicles and plant operating within the showground and the judging rings must not be altered by moving gates at any time. An exercise area for dogs will be provided adjacent to the caravan site.
